

**Community Safety and Health Policy**

**Scope**

This Community Health and Safety Policy is intended for Westports Holdings Berhad ("Westports" or "the Company") and all subsidiary companies within the Westports Group ("the Group"). It encompasses a comprehensive approach to community well-being and safety.

**Policy Statement**

Westports is dedicated to prioritising the health and safety of our community, employees, and all individuals within the vicinity of its operations. We are committed to maintaining a safe, secure, healthy environment through various Environment, Health and Safety ("EHS") Standard Operating Procedures, robust safety measures, efficient emergency response, and accessible healthcare services. Our primary objective is to enhance all stakeholders' safety, security and well-being.

The safety and security measures at Westports are of international standards, befitting a world-class shipping port. Westports Police, Fire & Rescue and EHS Department, established under the provision of the Police Act 1990 and Privatisation Agreement 1994, is empowered to strive to keep the port and Pulau Indah safe and crime-free.

Westports' Port Police and EHS Department responsibilities cover:

- Protecting the security of vessels at the wharves and cargoes at the yard
- Safeguarding the office building, facilities and other properties
- Ensuring industrial safety and supporting fire protection and prevention
- Patrolling services for the companies within the port premises, industrial and residential areas in Pulau Indah
- Facilitating and having traffic control on the roads in Pulau Indah
- Operating ambulance services for port users, employees and Pulau Indah residents
- Offering crime prevention support for commercial operators in Pulau Indah
- Serving on land rescue operations
- Providing Material Safety Data Sheet (MSDS) support on dangerous cargo handling, transportation and storage
- Delivering training on security, port police, industrial safety, fire prevention and rescue training for port users and staff
- Engaging in joint operations with the police department in curbing maritime crime
