Waste Management Policy

Scope

This Waste Management Policy is intended for Westports Holdings Berhad (“Westports” or “the Company”) and all subsidiary companies within the Westports Group (“the Group”).

This Waste Management Policy applies to all operations and activities conducted by Westports and its subsidiaries. It encompasses the management of scheduled, solid and municipal waste generated, waste recycling, waste disposal, effluent management and initiatives to reduce, reuse, or recycle wastes and effluents.

Policy Statement

Westports is committed to environmental stewardship and sustainability. We recognise our responsibility to minimise the impact of our operations on the environment by implementing the circular economy practices. Our waste management policy aims to:

- Optimise resource-use efficiency and minimise the impact of waste generation according to the sustainability development goals.
- Address the costs associated with waste impacts-
- Promote waste recycling and recovery consistent with the sustainable waste management hierarchy practice to minimise landfill disposal.
- Collaborate with others, where possible and suitable, to reduce pollution, waste or resource use through participation in local or global initiatives.
- Set time-specific targets beyond regulatory requirements to reduce or avoid waste, including quantified and unquantified targets.
- Report transparently on waste and effluent-related issues to stakeholders, including regulatory agencies and the public.
- Continuous awareness program in order to uphold the quality of the environment and the public health matters are being well preserved.

Policy Commitment to Manage or Reduce Effluents

Westports is committed to managing and reducing effluents generated from our operations to protect or minimise environmental impact and comply with all applicable laws and regulations.

We will actively seek and implement initiatives to reduce, reuse, or recycle effluents, promoting resource efficiency and environmental sustainability.

We will work collaboratively with our employees, suppliers, customers, and the community to achieve our waste reduction and environmental sustainability goals. Westports will periodically review and update this policy to ensure its continued effectiveness and alignment with evolving environmental standards and goals.
