

**Water Management Policy**

**Scope**

This Water Management Policy is intended for Westports Holdings Berhad ("Westports" or "the Company") and all subsidiary companies within the Westports Group ("the Group").

This policy applies to all water-related activities, resources, and processes within Westports' operations and facilities. It encompasses the responsible use, conservation, and protection of water resources to minimise environmental impacts and ensure sustainable practices.

**Definition**

Westports defines Water Management as the strategic planning, implementation, and monitoring of practices and initiatives aimed at sustainable and efficient water use, conservation, and protection to achieve economic, environmental and social goals.

**Policy Statement and Purpose**

We recognise the importance of water as a critical resource and are committed to managing our water resources responsibly, minimising environmental impacts, and contributing to a sustainable future.
